- III. Open Enrollment Applications Jolene Rod applied for open enrollment for her child to be admitted to the Dickinson Public Schools from Richardton/Taylor School District. Cassaundra Doshier-McClarren applied for open enrollment for her child to be admitted to DPS from Belfield Public School. Brian Farnsworth applied for open enrollment for his child to be admitted to DPS from South Heart Public Schools. These children did not attend Dickinson Public Schools at the conclusion of the 2014-2015 school year. The administrative recommendation is to approve the applications. Action is requested.
