As a Best in State team, the Dickinson High TSA won a \$5,000 award and recognition plaque. Each team member won a Verizon Ellipsis 10 tablet and case, a T-shirt, cinch backpack, bumper sticker, and the team qualifies to complete for the titles of Best in Region, Best in Nation, and Fan Favorite. They also compete for the most votes for the app concept with the winner receiving a \$15,000 award for their school; training from MIT experts to develop their concept into a working app; and an all-expenses-paid trip to the TSA Conference in June.
