NEW THIS YEAR - TWO-DAY FORMAT

The 2014 NDSBA Annual Convention will be held on Thursday and Friday ONLY, October 23-24, at the Ramkota Hotel in Bismarck. The New Member Seminar and School Law Seminar will be on Thursday, October 23.

The New Member Seminar on Thursday, October 23, is designed to meet the requirements of law mandating inservice training for newly elected school board members. Attendees will receive certificates of completion in the mail after the convention.

NEW THIS YEAR - SCHOOL LAW SEMINAR AND CONVENTION REGISTRATION ON ONE FORM

The School Law Seminar is now under the NDSBA Legal Services Program and will be administered along with the convention, so there will not be a separate check needed for the registration as in the past. The School Law Seminar is available as an option on the convention registration form.

Please review the enclosed information carefully. If you have questions about completing the registration form, please call our office.

Convention delegates and alternates must have their names submitted to the NDSBA office BY OCTOBER 10 in order to vote in the Delegate Assembly. There will be no exceptions! If you're not sure who will be attending, submit all possible names as either delegate or alternate. They will be allowed to **change** status at the convention only if their names were submitted by the deadline.

The formula for determining delegates is:

<u>Number of Teachers Employed</u>	<u>Number of Delegates</u>
0-10	1
11-30	2
31 and over	3

In addition, districts with a pupil population of 1,000 or more shall be authorized increased representation as follows:

<u>Pupils</u>	<u>Additional Delegates</u>
1,000-4,999	1
5,000 and over	2

The maximum number of delegates a district may have is five.

Only elected school board members may serve as delegates and alternates--administrators, county superintendents, and business managers are not eligible to vote. Counties and multidistricts are nonvoting members.

NOTE: Annual dues must be paid in order for delegates to vote at the annual convention.

FEATURED SPEAKERS



Timothy Q. Purdon was unanimously confirmed by the United States Senate as North Dakota's 18th U.S. Attorney on August 5, 2010. As U.S. Attorney, Tim has placed special emphasis on the issues of increasing public safety on the American Indian reservations in North Dakota, on national security and law enforcement cooperation along North Dakota's international border with Canada, and on working with federal, state, local and tribal law enforcement partners to counter the new threat from organized criminal enterprises that have targeted western North Dakota's Bakken oil boom region in recent years. Mr. Purdon is a graduate of the Hamline University School of Law, Moorhead State University, and the North Dakota State College of Science.

Sonja Trainor joined the legal staff of NSBA in January 2010 and became Director of COSA in September 2012. Ms. Trainor is responsible for developing and hosting programming and publications for Council members, including editing COSA's *Inquiry & Analysis* publication. She is part of the legal team, tracking litigation and legislative trends, and participating in NSBA's amicus process. Ms. Trainor is a graduate of the University of Illinois College of Law and Washington University.



Melanie Gurley Keeney is a shareholder at the law firm of Tueth, Keeney, Cooper, Mohan & Jackstadt P.C., in St. Louis, Missouri. Ms. Gurley Keeney practices in the areas of Employment, Immigration, and Education law. 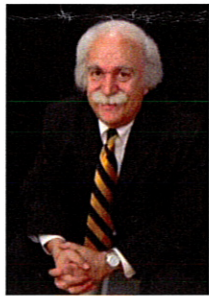
Opening Session – *Leading with Levity*
