Dear Mr. Jordheim:

This correspondence deals with the incident that occurred on Thursday evening, September 17, 2015, at Dickinson High School. Specifically, the incident was the verbal and threatening assault of Mr. Guy Fridley, the Activities Director of Dickinson High School. The incident was further complicated on Friday, September 18, when you made the comment to School Resource Officer, Josh Munson describing the type of new gun you had purchased.

Due to your behavior, I have no recourse but to impose the following consequences:

- You are not to be on Dickinson school property at any time.
- You are not to attend any Dickinson Public School activities both in Dickinson or another location outside of Dickinson.
- The remark made to Officer Josh Munson has also been referred to legal authorities.
- **These consequences are in effect until May 1, 2016.**

This incident was serious, and just because you do not agree with a decision by a coach or activity director, does not give you the right to verbally assault or intimidate a person.

Narrative

Primary Officer: Josh Monson 450

Synopsis: Guy Fridley informed me of an incident involving Brent Jordheim on 9/17/15 during a volleyball game. Guy stated that Brent confronted him about a volleyball issue with his daughter that happened last school year

Narrative: I was pulled into the Principals office to speak with Guy Fridley about an incident that happened at a volleyball game. I was told that Brent Jordheim came to his daughters volleyball game. Guy said "Hi" to Brent who replied back "you are a pussy ass bitch." I was told that Guy tried to talk to Brent about the issue but Guy was told "If we go somewhere, I can't promise something won't happen." I was then told that eventually they went to Guy's office at the high school and tried to talk about an issue that happened last school year with Brent's daughter during the volleyball season. Brent was upset at Guy and the volleyball coach Barman.

Guy wrote a statement about the incident, but stated that during the discussion with Brent, he felt he needed to keep his composure because he felt threatened by Brent and his demeanor during the time in the office.

The issue was discussed with school administration and it was decided to trespass Brent from school activities until further notice. I delivered a letter from the school district along with a parent standards of conduct policy. When I spoke to Brent at about 3pm on Friday 9/18/15 Brent told me the same story I heard from Guy. Brent stated he did call Guy a "pussy ass bitch." During my conversation with Brent, he made sure to tell me he recently purchased and received a short barreled Sig rifle. He did not make any direct threat but felt it was appropriate to tell me about the rifle.

I was given copies of the letter from the school district, statement from Guy, the parent standards of conduct and a statement from Jamie Krebs who was selling tickets to the game.

Guy and the school district wanted this a matter of record for the time being unless something else happens with Brent.

To whom it may concern,

Last night (9/17/15) I was taking tickets at the Volleyball match at DHS. Guy came to the ticket booth to check on things and to make sure things were going well. At that time a gentleman came to the booth and I asked "1 adult" he said "yes" I then said "that'll be \$6 please". As he was getting his money out Guy said "hi" and the gentleman didn't reply, Guy then said "hi Brent" and he responded with "...you pussy ass bitch". At that time Guy said "excuse me" and Brent said "you heard me you pussy ass bitch". More was said between the two (I was not able to catch it all because I was trying to take money the game). At one point I heard Brent say something about Guy defending that bitch basketball coach of his – Guy was very calm and asked him to step away to talk about what he was upset about because he didn't know where all of it was coming from. At first Brent didn't say anything but when Guy asked "Lets step into the office so we can talk about this so I know what is going on", Brent said something to the effect of...'You don't want to go behind closed doors with me'. Eventually Guy talked Brent into going into the office to talk about the situation.

During the time of the confrontation I felt **VERY** uncomfortable and at times scared. I was trying to take money for the guests that were wanting to attend the Volleyball game and they were having to go around Brent since he was standing in the middle of the booth. This happened during a busier time of ticket sales. When Guy and Brent went into the office I was extremely nervous for Guy and his safety. About 20 minutes went by and he was still in the office and at that time I was hoping Candace or Ron would walk by so I could have them go into the office to check on Guy and to make sure he was okay.

Eventually Brent came out, bought a ticket, and attended the Volleyball game.

Brent Jordhiem Incident

9/17/15

Between the JV volleyball game and the varsity game, I went out to visit with Jamie Krebs (ticket taker) to see how things were going and to see if she needed anything. While Jamie and I were talking, Brent Jordheim came in. I proceeded to say "hi Brent". He looked at me and looked away. I said again, "hi Brent, how are you tonight". Brent responded by saying "you are a pussy ass bitch". I responded by saying excuse me. He again says "you are a pussy". I responded by saying I don't get why you are saying that and I will remove you from the facility. He said you can't do that. I responded by saying "what is your problem, let's go to my office and get this cleared up because I don't know where you are coming from." He said, "if we go somewhere, I can't promise you something won't happen". He followed me into my office.

While in my office I asked him "I don't know where you are coming from by calling me a pussy ass bitch" His response was "because you are one" He proceeded to say that I have no balls for what Barman did to his daughter and I stuck up for Barman. He said "all you said at that time was you understood both sides." My response was "that is true, I did say that because I understand that you wanted to bring and I understand that the coach wanted her to stay here in play and that is what I meant by I understand both sides."

He continued to belittle Coach Barman and he said "I have a \$1,000 reward at three bars in town for her to get a DUI and money talks." He continued to call Barman a drunk and that she is going to destroy the program and hopes they have a terrible year.

I continued to ask him I still don't get where you think you can call me a pussy ass bitch. He responded by saying "you have no balls and you won't fire anyone and everyone knows it." I said "I have no issue firing someone if it is warranted." He said you never allowed us to meet with you and Coach Barman. I responded by saying "yes I did and I called you requesting that we meet to clear things up". Your response at that time was "I can't meet with her because I don't know what I would do and I would of done something to get back in jail". I said, "but I gave you an opportunity to meet, correct". He said "oh yeah, that is right you did but I was so mad I did not want to look at that bitch."

During our conversation at some point he mentioned that it is freedom of speech to call me a pussy ass bitch. I said "not here it is not, that is grounds to be removed and be removed for good". He did not understand that what he said was wrong to say to anyone inside a school.

At the end he goes, either I leave or go watch. I was waiting for an apology. He goes "I guess I apologize". My response was "go watch your daughter".

I needed to keep my composure the entire time because I felt threatened by his demeanor and his lack of control. Bottom-line, he is still mad about Coach Barman having Lexi play in a freshman game last year and he feels that ridiculed her.
