TWO-DAY FORMAT

The 2015 NDSBA Annual Convention will be held on Thursday and Friday, October 29-30, at the Ramkota Hotel in Bismarck. The New Member Seminar and School Law Seminar will be on Thursday, October 29.

The New Member Seminar is designed to meet the requirements of law mandating inservice training for newly elected school board members. Attendees will receive certificates of completion in the mail after the convention.

SCHOOL LAW SEMINAR AND CONVENTION REGISTRATION ON ONE FORM

The School Law Seminar is now under the NDSBA Legal Services Program and will be administered along with the convention. Registration for the School Law Seminar is available as an option on the convention registration form.

Please review the enclosed information carefully. If you have questions about completing the registration form, please call our office.

Convention delegates and alternates must have their names submitted to the NDSBA office BY OCTOBER 16 in order to vote in the Delegate Assembly. There will be no exceptions! If you're not sure who will be attending, submit all possible names as either delegate or alternate. They will be allowed to **change** status at the convention only if their names were submitted by the deadline.

The formula for determining delegates is:

<u>Number of Teachers Employed</u>	<u>Number of Delegates</u>
0-10	1
11-30	2
31 and over	3

In addition, districts with a pupil population of 1,000 or more shall be authorized increased representation as follows:

<u>Pupils</u>	<u>Additional Delegates</u>
1,000-4,999	1
5,000 and over	2

The maximum number of delegates a district may have is five.

Only elected school board members may serve as delegates and alternates--administrators, county superintendents, and business managers are not eligible to vote. Counties and multidistricts are nonvoting members.

NOTE: Annual dues must be paid in order for delegates to vote at the annual convention.

FEATURED SPEAKERS



Ed Massey is a licensed attorney in the states of Ohio, Kentucky, and Indiana and is a past president of the National School Boards Association. For the past 18 years, Mr. Massey has been involved in school board work having served on the Boone County, Kentucky, Board of Education and as president of the Kentucky School Boards Association. He will discuss use of social media in the school setting.

Jim Long, former Senior Attorney with the Office for Civil Rights (OCR), will present information on OCR complaints and the investigation and review process. Mr. Long will discuss best practices for assisting school districts in navigating the complete process, while providing insight into OCR's investigatory posture in cases alleging discrimination.



Thomas E. Myers, partner at the law firm of Brackett & Ellis, P.C., Fort Worth, Texas, will discuss FERPA and the rights and responsibilities of school districts regarding this federal law. Mr. Myers has practiced in the area of school law for over 20 years, representing boards of numerous school districts. He is a frequent speaker at state and national education conferences.

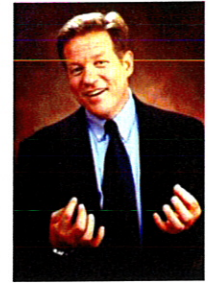
