- Have to have title IX title VII coordinator
- Need to investigate as well as inform police

The last speaker of the day spoke on A challenge to nd tort caps

- Nd law limits liability limit at \$250,000.00 per person or \$500,000.00 if more than 3 people
- Constitutional argument
- Political subdivisions are not like regular citizens duty to provide essential services
- Judge denied argument determined ndcc 32-12-1-03 is constitutional
- Defendants appealed to nd Supreme Court
