

Classified Leadership Minutes

Tuesday, December 12, 2023; 1:30 p.m.

- I. Call to Order: Dr. Lewton called the meeting to order at 1:32.

 - 1) Review the December 11, 2023, School Board Meeting Agenda- Enrollment is up 133 students from December 2022.

CMAR bids will be opened tonight by Mr. Harris and others, interviews will be held on December 19th with a recommendation to the School Board on December 21st.

Sheila asked if there has been any more discussion about boundary changes and Dr. Lewton noted there is a meeting with RSP next week. They have been tasked with providing some options for boundary changes using the information from the study done 2 years ago. We did not want to pay for a whole new study this time as that is expensive.

Dr. Lewton reported that the School Board approved 7 additional certified positions for next school year. Those positions will mainly be in Special Education and at DMS and the CTE Academy.

Bond Referendum Update: We have applied for a loan for \$15 million at 2% interest, which is lower than what was expected and will save the public money.

- Classified Receive 3 Personal Days; Certified Receive 13 PTO Days Sheila brought up the difference between classified and certified time off. Dr. Lewton referenced the February 2022 meeting minutes where classified staff rejected the offer to switch to PTO days, as the certified staff did. Heidi noted it was rejected at that time because to do so, classified staff would lose 3 days of time off in the conversion. Dr. Lewton asked if we would like to revisit this at this time and the group declined. He noted we could revisit it at any time if classified staff would like to.
