TWO-DAY FORMAT

The 2016 NDSBA Annual Convention will be held on Thursday and Friday, October 27-28, at the Ramkota Hotel in Bismarck. The New Member Seminar and School Law Seminar will be on Thursday, October 27.

The New Member Seminar is designed to meet the requirements of law mandating in-service training for newly elected school board members. Attendees will receive certificates of completion in the mail after the convention.

SCHOOL LAW SEMINAR AND CONVENTION REGISTRATION ON ONE FORM

The School Law Seminar is now under the NDSBA Legal Services Program and will be administered along with the convention. Registration for the School Law Seminar is available as an option on the convention registration form.

Please review the enclosed information carefully. If you have questions about completing the registration form, please call our office.

Convention delegates and alternates must have their names submitted to the NDSBA office BY OCTOBER 14 in order to vote in the Delegate Assembly. There will be no exceptions! If you're not sure who will be attending, submit all possible names as either delegate or alternate. They will be allowed to change status at the convention only if their names were submitted by the deadline.

The formula for determining delegates is:

Number of Teachers Employed	Number of Delegates		
0-10	1		
11-30	2		
31 and over	3		

In addition, districts with a pupil population of 1,000 or more shall be authorized increased representation as follows:

<u>Pupils</u>	Additional Delegates
1,000-4,999	1
5,000 and over	2

The maximum number of delegates a district may have is five.

Only elected school board members may serve as delegates and alternates—administrators, county superintendents, and business managers are not eligible to vote. Counties and multidistricts are nonvoting members.

NOTE: Annual dues must be paid in order for delegates to vote at the annual convention.

Erin Gilsbach is an experienced speaker at the state and national levels on issues regarding education and education law. She is the Director of Professional and Policy Development and an attorney with the Pennsylvania-based law firm of King, Spry, Herman, Freund & Faul and a founding member of the Greyfriars Institute, a nonprofit affiliate entity dedicated to providing quality professional education in the area of school law to educators and school leaders. She provides legal representation and/or professional development to over 150 Pennsylvania schools.

In her practice, Gilsbach emphasizes a proactive approach to legal defensibility for schools through education on school law topics and by helping them to create procedures, administrative regulations, and board policies that are developed not only upon consideration of statutory and regulatory requirements but also the best practices and common pitfalls found within the facts of applicable case law.

Troy Seibel was appointed North Dakota's Commissioner of Labor by Governor Jack Dalrymple in September 2014. As Labor Commissioner, Troy oversees the North Dakota Department of Labor and Human Rights, which is responsible for the enforcement and education of North Dakota's labor, human rights and housing laws.

Prior to his appointment, Troy was an assistant attorney general with the North Dakota Attorney General's Office, where he served as legal counsel for the department and handled employment matters for various state agencies. Prior to joining the Attorney General's office, Troy was in private practice for 11 years.
