<u>FAFSA</u>-(Free Application for Student Aid)— Available on-line as of October 1, 2021. Federal income tax returns from 2020 may be used before January 1, 2021. Income will interface on FAFSA after 2020 taxes are filed. Make sure to use www.fafsa.ed.gov as this is a free application. The automatic ND State Grant is also based on the FAFSA. It is a first-come first-serve grant.

Seniors: Retaking the ACT: If you were not happy with your ACT score, you still have time to retake it for a better score! Your highest score will be the one that counts for college admission and scholarship purposes. Pick up a paper practice test from any counselor and/or use the many free on-line resources to help you study. Students may sign up at www.actstudent.org. The deadline to register for the February 12 test is January 7.

<u>Dickinson Dollars for Scholars:</u> Students in grades 9-12 are invited to become a volunteer with Dickinson Dollars for Scholars and are encouraged to attend their meetings on the 3rd Tuesday of every month. These take place at the Dickinson Chamber of Commerce building. This helps open the door to various scholarship opportunities at the local, state, and national level.

<u>Dual Credit:</u> Students who are interested in taking classes for dual credit and qualify for free-or-reduced lunches can register for up to two dual credit classes in the fall and/or spring and have them paid for by the ND College Access Network (NDCAN) through the Bank

of ND. Students do not have to eat school lunch in order to qualify. Visit with your dual credit teacher or a counselor for more information[©]

<u>ALC/Tutoring:</u> Students struggling in any subject should visit with their teacher as soon as it starts. Teachers can help directly and/or refer them to the Academic Learning Center (ALC), which is open from 7:30am until 4:15pm—it is open the entire day, including over lunch.

<u>Test Anxiety</u>—Testing provides a healthy challenge for students and helps them measure what they have learned. Teens have grown up in an era of high-stakes standardized testing. Finals time at the end of each grading period can cause high stress—encourage them to study in an appropriate environment and to learn strong study skills. Also, encourage plenty of rest and healthy eating habits.



<u>College/University Visits</u>—This is a great time of year to schedule college visits/tours! Watch for open house dates at the schools you are interested in attending; these can be found on their websites. Stop in and see your senior counselor if you need help making contacts.

NCAA—NCAA Eligibility Center checks academic eligibility for students who want to play sports at a Division I or II level. Make sure that you complete your online NCAA application and that you have your official transcript sent from the front office at the time that you complete your application and at the end of the school year.

<u>Career Planning</u>— The best tool in helping your student plan their future is to help them know him/herself. Encourage them to take a variety of elective courses and schedule job shadows to help explore different interest areas. It is never too early to start discussing options and goals! Students need to be realistic about their career choice and know what is expected in that career—also be aware of the future labor market demands. ND State Academic/CTE Scholarship: This \$6,000.00 scholarship is available to all student at almost all ND colleges and universities as long as they meet the qualifications. \$1,500.00 is awarded per year for four years (\$750.00 per semester).
